“A police pursuit will be initiated in situations where the driver or passenger has committed, or is about to commit, an indictable (dual procedure) offence and immediate apprehension is required to prevent imminent harm to a person; and that possession of stolen vehicles, Motor Vehicle Act offences and municipal by-law offences do not in themselves constitute offences that pose imminent harm to the public, and therefore do not justify pursuits.”


