**CHIEF’S REPORT FOR NELSON POLICE BOARD MEETING**  
**June 12<sup>th</sup>, 2007**

*Regular Meeting*

**Calls for Service May 17 – June 12, 2007**

According to the PRIME RMS, Nelson Police fielded 445 calls during the 26 day period from the last meeting, or an average of 17 calls for service per day. This does not include the calls that are written off in the CAD and did not generate a GO (General Occurrence report).

This is up slightly and consistent with seasonal influx. We continue to be challenged by a high percentage of calls for service and emergencies generated by Emotionally Disturbed Persons, both transients and residents of the community. Individuals with personality disorders and marginal mental disorders who engage in threatening behaviours and criminal conduct often “fall between the cracks,” in terms of the unwillingness of the criminal justice system to prosecute and the unwillingness of our Healthcare System to house and treat them. Arrests typically result in the revolving door of very short term detention and medication, followed by a spiral of aberrant behaviour, abstinence from medication, alcohol and illicit drug use and re-arrest.

Along with increased responsibility for managing those with mental problems, we continue to be challenged by the effects of alcohol abuse in our community, accounting for the majority of our weekend arrests and the major contributor to domestic disturbances. On the plus side, it would appear that a societal shift commensurate with a “zero tolerance” policy on behalf of Crown Counsel and the police has had a positive result in the area of domestic disturbances. More domestic disturbances are being reported to police, but fewer are resulting in actual assaults. This could be an emerging trend worthy of monitoring and celebrating, if in fact more women are having the courage to come forward and report abuses before they turn to physical violence; and, if in fact men are being deterred from resorting to violence.

**Noteworthy Developments**

- The entire Department was successfully transition trained on the new issue Glock 22 pistols, all members qualifying with ease on the BC50 Course of Fire. A new partnership has been struck with the Nelson Rod & Gun Club, for the Nelson Police to exclusively use their facilities for training. Cst. Brian Weber, a previous instructor with the Justice Institute of BC and former member of the Port Moody Police, facilitated the training.
- Council approved the increased expenditure for the Nelson Police 9-1-1 Communications Upgrade, which will bring an entire IT overhaul to the

Department, including digital camera capture and recording of the cell block. Work on this project has commenced, with completion estimated by Fall.

- I had the opportunity to give a welcome address to the Southeast District RCMP Traffic Commanders at their meeting hosted in Nelson on June 6<sup>th</sup>, 2007. Sgt. Fred Mansveld received an award of recognition at that meeting for his initiative and exemplary command of the Integrated Road Safety Unit (IRSU). This unit continues to provide tremendous public safety results, such as the arrests of 16 impaired drivers in Castlegar over the SunFest weekend, some of whom were no doubt headed to Nelson.
- Demands for volunteer participation by the Nelson Police continue to grow. Work has begun on the mowing of the Observatory St. interchange connecting Uphill to Rosemont, and we have 14 volunteers on a signup sheet to date.
- The Special Parks Unit, a core group of dedicated of Nelson Reserve officers, has been deployed to conduct anti-vandalism and deterrence efforts throughout the City parks, and is already starting to show positive results. Many public complaints have been received about the abuse of the parks by vandals, squatters and other unwelcome users. It is our sincere hope that the deterrent effect of the SPU will keep our parks safe and free from harm with the onset of Summer.
- Our Crime Prevention Officer, Cst. Bill Andreaschuk, has successfully spearheaded a comprehensive Anti-Graffiti campaign in Nelson by partnering with local business, the Rotary Club and a host of volunteers. These individuals are mobilizing to combat graffiti with immediate repaints once reported, deterring future vandals and restoring the look of the victimized buildings.
- Nelson Police will be conducting a Joint Forces Operation with the Canadian Pacific Railway Police in the near future, to eliminate squatter camps adjacent to the City. These camps pose a serious health and fire risk to the Nelson, and the trespassing often ends in human/train conflict, injury or death. Earlier this year, a mountain biker on the CP property lost his foot after colliding with a train.
